Welcome & Introductions

• Antwan Campbell: This is a non CEU bearing event, if you intended to come for the CEUs for the Road Trip you are a bit early and we welcome you to stay and attend

Tanya Miller – Motion to approve board meeting minutes from November meeting Trula Baker - Seconded Motion passes unanimously

President's Report

- RID
 - Region II, Shonna Magee is the Region II representative on the committee for affiliate chapters, no names received from NCRID board
 - Meet and Greet with Regional Representative Jason Hurdich & Carolyn Ball was schedule for March 8th, that will be rescheduled. Action Items: Antwan will send a poll/request to the NCRID Board to determine another date. This date must be on a Mon, Tues or Wed in the evening and would be in latter March or early April
 - Region II conference this summer leadership conference, talk about your positions and how you can successfully run an affiliate chapter, more information to come
- ITP Issues Two Issues to discuss and develop a response
 - Joni Hedrick: PreCert this term is misleading, and some consumers are 0 concerned about the use of the terp pre-certified or similar terms when in actuality an individual has no RID recognized credential. Joni Hedrick update, a few weeks ago, the NCRID board met and had a working retreat and discussed this issue, we planned to develop a response as a Board incorporating NCAD and NCASLTA within the response. We identified two deaf individuals (Jaime Marshall, NCAD Secretary and Dr. Jordan Wright, research and writer currently an Assistant Professor and NTID) to research the issue and draft a response that would be reviewed. Since that time, it was discovered that RID has developed and shared a position statement on this exact issue in July 2019. This is not a new problem. During the meeting all attendees viewed the video post of the statement on RID's website found at this link: RID Position Statement on Misrepresentation of Certifications and Credentials – Registry of Interpreters for the Deaf
 - Discussion of the PreCert: Seems there is no longer a need for a letter to 0 RID because it has already been addressed. Trula Baker: We can still highlight the issue and RID's previous response as it seems to be resurfacing as an issue. Joni Hedrick: Yes, we need to pivot on our response and action item. RID has already addressed this, no need for a letter, just a reminder that there is already an official statement. Rose Fichera-Lening, instructor at Blue Ridge Community College: Will the 'letter' or statement go out to RID as well as agencies? Joni Hedrick: suggest that we amend our previous action item of writing a letter and instead NCRID can share RID's position statement and link the actual video across our social media and website. Rachel Skipper: We can also include this in the newsletter to members. Joni Hedrick: Regarding making the ITPs aware, we have board members that are frequently contacting the ITPs and are happy to review and share information disseminated from RID. We will intentionally make sure the ITPs get this information. We have had difficulty getting ITP coordinators to respond and would like stronger partnerships with ITPs in the future. Trula Baker: To those attending today's meeting from ITP programs, there is a regional

representative on this board for every area where this an ITP program, reach out your regional representative or to us and we will be happy to support you. Rose Fichera-Lening: What is the preferred statement on students' business cards? Antwan Campbell: For NC, their NCITLB license # is all that is needed. Rose Fischer-Lening: BRCC's students complete portfolios and resumes to reflect their experience and put "ASL/English Interpreter" on their business cards. Students are clearly instructed they need to be provisionally licensed with NCITLB. Trula Baker: The NCITLB website states how they put information on a business card, if it does not follow that format they are in violation. Joni Hedrick: To make a distinction, the issue were are discussing about the term PreCertified as a term is not a licensure issue, this was an RID credentialing representation issue, was a national and credentialing issue, on a business card they could only truly use "non-certified" as that's the only status of certification that is accurate.

- Second ITP issue to discuss December Graduates. Trula Baker: This
 issue is related to complimentary membership. All May graduates are
 given a free 1 year membership, so for Dec graduates we need to know
 what to do, is it 6 months or 1 year, want to discuss this at our next face to
 face board meeting, possible idea 6 months free then in July they could
 join as non-voting member half the cost
 - Trula Baker explained the process for students to obtain their one year complimentary membership. Every year in April & May Trula sends every ITP coordinator information regarding the membership, an attachment of the membership form, the link to submitting membership online and a request to the ITP coordinator to return to Trula a list of December graduates' names. Students contact Trula with a completed membership form. Trula does not send membership cards to everyone graduating because there needs to be involvement/action from the students, all of that is sent to the ITP coordinators and is available to students if ITP coordinators share the information. In 2021, Trula received names of 31 graduates. Info obtained from 4 ITP programs. Three programs never responded.
 - Trula Baker discussed starting the complimentary membership earlier during their senior year and including people who are graduating in December. Antwan Campbell: would help them be established and connected in the profession. Trula Baker: From August through June they could take advantage of many workshops at a free or reduced rate, more of a benefit to give it to them while they are in the last year of their program. Antwan Campbell: If we followed this idea, for this year it would include 2022 and 2023 graduates. Caroline Bolin: likes the proposal and also what should we do for 2021 graduates? Those individuals will contact Trula. Antwarn: and Dec 2021 graduates will be included

in the 2022 group of student complimentary memberships. Trula: this should be information that the ITP coordinators have and if that information is missing the students should be asking their coordinators why. The hope is that the complimentary membership will lead students to becoming involved and paying members.

- Trula Baker: Motion to go forward with starting new student complimentary memberships during the senior year of the ITP program beginning with the Dec 2021 graduates and forward.
- Caroline Bolin: Seconded
- Motion passes unanimously
- Other issue: Joni series of complaints that have occurred in VRS around individuals changing their voice to match the race of the person they are interpreting for and it seems that recent graduates may be trending in that area, message equivalence to sound like another race or what they perceive that race would sound like

Clearly that is inappropriate - other discussion

Trula: we need to take a stand on, that is oppression, cannot assume that is what a person would sound like

Rachel Skipper: many internal thoughts and feelings about that, cannot speak to this completely as I am a white person and of the majority, if we do create a response we need to involve members of that community to create a response

Tanya: same suggestion, reach out to the community and represent what the community wants and not only us, agree with Rachel

Matt Baccari – agree with all board members, we should have a stance, having a diverse set of voices is the way to go

Antwan – needs to be corrected immediately, has come up in VRS and in roundtables and using message equivalence, race does not have a sound

Holly – message equivalence has nothing to do with subjectively assigning race or even gender to a message, my experience with VRS is that is not promoted and is addressed

Membership/Treasurer Report (Trula Baker)

- Change in working capital: \$43,721.84 (after the \$25,000 was transferred into savings, also does not include our conference seed money, financially we are in good shape)
- Board Retreat final cost for mileage, meals, hotel was \$2,068.87 (may sound like a lot but we have not had face to face board meetings for 2 years and looking back it is on par with what we spent previously when meeting in-person, within our budget)
- Mikki Simpson PD fund fund for stipends for persons who are sitting for the written or performance test \$100 once you take, pass, and provide documentation, that fund have \$1,812.73 (there for our members to take advantage of testing costs)
- Rachel Skipper if someone wanted to apply for the Mikki Simpson stipend need to be a member (current member) and what certifications is it for? Any recognized exam

- Holly Brigman Can NCRID members can apply for the Mikki Simpson stipend and use that for the cost of an EIPA test as well? Trula – yes. Holly Brigman – Can donations made to NCRID be designated for the Mikki Simpson fund? Trula - yes.
- Trula Baker: Two presenters waived their presenter fee be donated to the VA Association for the Deaf Blind - \$50 contribution used to serve DB population in VA
- We are on a non-profit list for receiving donations, something affiliated with Duke Energy receive \$32 monthly
- MembershipUpdate : 230 members (down from previous years), 134 voting, 67 non-voting, 21 student members (17 paid, 4 complimentary), 8 organizations
- Voting member with NCRID requires RID membership
- Antwan Campbell Someone can join as a student member or an associate member of RID
- Trula Baker: Student membership photo ID required, if you do not have that send a copy of current class schedule
- Still waiting on an answer about a D&O insurance? (insurance to cover us as board members for liabilities to NCRID, it's for protection against lawsuits and litigation)

Conference Report

- June 24-25, virtual same as last year, not hybrid
- Not sure what it will look like just yet, nothing released, watch social media
- Has not been a priority, if anyone would like to help with that would be great
- Something official should be coming by the end of March
- Registration open April 1st
- Antwan: assistance needed in what form? Joni will send a list out.
- Antwan: last year with virtual we had mostly in-state attendees, when it is in-person we tend to have more out of state attendees

Media Report – Matt Baccari

- Social media accounts getting access to all existing FB pages, different regions there were old pages, now we have access to all of them
- Midstate and Eastern we posted a call for nominations
- February plotted out the entire month on a calendar of when to share and scheduled posts, goal was to have more consistent activity, helped to make the process more efficient and will follow this process moving forward
- Looking into Apps for prescheduling posts that ensure the posts are uploaded quickly following the schedule without requiring activity for
- Feb/March newsletter suggestions to add, love for a region to be spotlighted in this newsletter, Land O'Sky was spotlighted who was on the committee, what their work looks like
- Software for elections has been used in the past, easy to use, will work well with bylaws and other
