### Workshop Description

Are you preparing for national interpreter certification? Are you interested in learning more about the new CASLI exams? In this overview, we will look at each of the exams, including both parts of the Knowledge Exam, which both Deaf and hearing interpreters take. We will also discuss both Performance Exams – the one for hearing interpreters and the one for Deaf interpreters. The new list of recommended readings will be shared along with some additional resources and study materials.

CASLI is the Center for the Assessment of Sign Language Interpretation. We will discuss the following exams:

- CASLI Generalist Knowledge Exam (CGKE): The Foundations of Interpreting (multiple choice)
- CASLI Generalist Knowledge Exam (CGKE): Ethical Decision-Making and Cultural Responsiveness Exam (multi-step case studies)
- CASLI Generalist Performance Exam (CGPE) for hearing interpreters (also called the Hearing Interpreter Performance Exam (HIPE))
- CASLI Generalist Performance Exam (CGPE) for Deaf interpreters (also called the Deaf Interpreter Performance Exam (DIPE))
